

# Privacy Policy

Cool Japan Fund Inc. (hereinafter referred to as “CJF”) will handle personal information that it acquires and uses as set forth below.

## **1. CJF’s Stance on Protection of Personal Information**

CJF understands the importance of protecting personal information and will protect such information when acquiring, using, managing and otherwise handling it.

## **2. Compliance**

CJF will handle personal information in compliance with the Act on the Protection of Personal Information, other applicable laws, ordinances and guidelines and with generally accepted norms and rules.

## **3. Purposes of Use of Personal Information**

CJF will acquire and use personal information solely to the extent necessary to fulfill the purposes described below.

- (1) The purpose of investing in enterprises subject to support or giving advice to enterprises engaging in subject business activities
- (2) The purpose of offering information on CJF’s business activities and suchlike
- (3) The purpose of communication concerning events and others organized by CJF
- (4) The purpose of responding to inquiries to CJF and consultation on investment
- (5) The purpose of conducting other operations of CJF stipulated by the Act on Cool Japan Fund, Inc.

## **4. Disclosure to Third Parties**

CJF will not disclose to any third party personal information it acquires except where consent is obtained from the information owner or where the disclosure is required by law, ordinance or equivalent.

## **5. Ensuring of Security**

CJF will take appropriate measures to prevent any loss, destruction, falsification or leakage of or unauthorized access to personal information acquired and will ensure that the personal information is handled securely.

## **6. Requests on Personal Information**

CJF will properly consider and respond to requests for disclosure, correction, suspension of use, deletion or others regarding personal information it has acquired in accordance with laws and ordinances. CJF will explain the specific procedures for any such request on a case-by-case basis. Please contact CJF using the contact information specified in paragraph 9 of this Policy.
